







INTRODUCTION

The Appellate Court in Kragujevac was founded on 1 January 2010 with territorial jurisdiction over higher courts in Jagodina, Kragujevac, Kruševac, Kraljevo, Novi Pazar, Čačak and Užice (Law on the Seats and Territorial Jurisdictions of Courts and Public Prosecutors' Offices, Official Gazette of the Republic of Serbia, no. 116/08). As of 1 January 2014, the Appellate Court in Kragujevac also has territorial jurisdiction over the Higher Court in Požarevac (Law on Seats and Territorial Jurisdictions of Courts and Public Prosecutor's Offices, Official Gazette of the Republic of Serbia, no. 101/13).

Under Article 24 of the Law on Organization of Courts, the Appellate Court decides on the appeals against the decisions of higher courts, the decisions of basic courts in criminal proceedings provided that the higher court has no jurisdiction to decide on the appeal, and the decisions of basic courts in civil matter cases provided that the higher court has no jurisdiction to decide on the appeal, on conflicts of jurisdiction of lower courts in its jurisdiction provided that the higher court has no jurisdiction to decide, on the transfer of jurisdiction of basic and higher courts when they are prevented or unable to act in a legal matter and performs other tasks specified by law.



On 31 December 2017, in all courts in the territorial jurisdiction of the Appellate Court in Kragujevac, out of 502 judicial positions determined by the Decision of the High Court Council, 454 positions were filled, while 449 judges were effectively working.

According to the Law on Budget for 2017, all courts were financed from the budget with RSD 20,985,969,000.00, which was 1.86% of the entire budget of the Republic of Serbia which totaled RSD 1,123,195,679,000.00 for 2017

In 2017, RSD 292,600,822.00 was designated for the Appellate Court in Kragujevac.

Higher courts in the territorial jurisdiction of the Appellate Court in Kragujevac received RSD 788,672,582.41, while basic courts received RSD 2,658,798,577.55.

DISPOSED CASES IN 2017


Over the course of 2017, all courts in the territorial jurisdiction of the Appellate Court in Kragujevac, including the Appellate Court itself, disposed 299,945 cases. In comparison to 2016, the total number of cases disposed decreased by 90,469, given the limited impact of the new Law on Enforcement and Security on 2016 which is missing in 2017 The number of disposed enforcement cases in 2017 dropped significantly because there are no more extraordinary systemic interventions to solve these cases.


The figures above encompass all types of trial and enforcement cases. **Excluding** enforcement cases, the number of disposed cases in 2017 increased by 36,714 in comparison to 2016.

The Table below presents a comparative overview of the trend in the numbers of disposed cases in all the courts in the territorial jurisdiction of the Appellate Court in Kragujevac from 2014 until 2017, with and without enforcements cases.

Moreover, basic courts in the territorial jurisdiction of the Appellate Court in Kragujevac disposed 116,776 cases in 2017 upon requests of the citizens for verification of signatures, manuscripts and transcripts, issuing certificates, rogatories, etc. that are not shown in these tables, while higher courts disposed an additional 1,330 cases of this type.





The chart shows a conspicuous trend of constant increase in the number of disposed cases in the courts in the territorial jurisdiction of the Appellate Court in Kragujevac, excluding enforcement cases.

INCOMING CASES IN 2017

Comparative data on incoming cases in all the courts in the territorial jurisdiction of the Appellate Court in Kragujevac (the inflow of cases and cases being processed again, but previously classified as disposed) indicate a significant increase of inflow in 2015, 2016 and 2017 (excluding enforcement cases). In 2017, 275,645 cases in total were received, and excluding enforcement cases – 259,833, whereas at the end of 2014 there were 174,825 such cases received.

The largest incoming caseload when compared to the previous period was recorded in civil departments of higher courts where in 2016 in "P", "P1", "P2", "P3" and "P4" matters a total of 4,010 cases were received, and in 2017 – 24,495 cases.

These were, for the most part, the cases filed on the same grounds (army reservists). The increase in incoming cases by 20,845 placed a severe strain on the existing capacities of higher courts which was impossible to offset even through a considerably increased number of disposed cases in this matter.

However, the inflow of cases without enforcement in the previous years has not been cleared in its entirety. Clearance rate, without enforcement, below 100% shows that the judicial system with its existing capacities is not capable of absorbing the increased inflow of cases, but requires systemic measures to overcome this shortcoming.

PENDING CASES AT THE END OF 2017


Comparative indicators for the 2014-2017 period show a significant decrease in the number of pending cases in all the courts in the territorial jurisdiction of the Appellate Court in Kragujevac as at the end of 2017 the number of pending cases was reduced by 181,532 in comparison to 2014 where there were 370,183 pending cases.


In 2014, there were 370,183 pending cases, and at the end of 2017 there were 188,651 pending cases, including enforcement cases.



Decrease in the number of pending cases is for the most part the result of the above-mentioned systemic interventions, i.e. the application of the Law on Enforcement and Security (Official Gazette of the Republic of Serbia, nos. 106/15, 106/16 and 113/17).

At the same time, increase in the number of pending cases without enforcement pertains to the increased number of incoming cases which the courts with their existing capacities could not clear.







In predominantly trial cases, the number of pending cases is shown in tables below.







RATIO OF INCOMING, DISPOSED AND PENDING CASES


The ratio of incoming, disposed and pending cases in the 2014-2017 period shows a decrease in the pending caseload at the end of the reporting period, despite the enormous increase of inflow, which is the consequence of the increased total number of disposed cases, resulting from the increased engagement of judges and systemic measures undertaken to reduce the backlog.


REPORT ON THE WORK OF THE APPELLATE COURT IN KRAGUJEVAC

The comparative performance overview shows that the Appellate Court in Kragujevac in the 2014-2017 period had constantly a large inflow of cases, which was approximately the same in the past three years, as well as that the number of pending cases is constantly decreasing.









OVERVIEW OF THE WORK OF THE APPELLATE COURT IN KRAGUJEVAC IN 2017

In 2017, there were 45 working judges in the Appellate Court in Kragujevac, even though 53 judicial positions were determined by the Decision of the High Court Council.

The number of incoming cases was almost on a par with the last year's inflow of cases, albeit slightly lower; 13,307 cases were received and 13,487 cases were disposed. The clearance rate totaled 101,35%.

Decisions on merits resulted in 13,012 disposed cases, or 96.48%; the percentage of revoked decisions was 4.71%, and the overall quality of the work of the court totaled 99.25%.

The goals of the Backlog Reduction Scheme in 2017 for the Appellate Court in Kragujevac were accomplished for the most part.

The number of backlog cases by the date of receipt at the Appellate Court in Kragujevac decreased and amounted to 175 cases, or 5% of the total number of pending cases which constitutes a significant reduction in comparison to the previous year when the number of pending backlog cases by the date of receipt at the court was 340 cases, or 9.25% of the total number of pending cases.

There was also a decrease in the number of backlog cases in which the proceedings on appeal were still pending for over a year in comparison to the previous year (from 29 to 11).

Compared to 2016, the oldest cases in which the proceedings take more than five years from the date of filing of the initial act make up a smaller percentage of the number of total pending cases at the end of 2017 (2016 – 22.70%, 2017 – 20.63%).

In addition to proceedings on appeals, in the course of 2017, the Appellate Court was monitoring the implementation of the Backlog Reduction Scheme in lower instance courts in the territorial jurisdiction of the Appellate Court in Kragujevac, which had been adopted by the President of the Appellate Court in Kragujevac.


For the purpose of harmonization of court practice, many activities were undertaken preceding the meetings of all appellate courts, pursuant to the Agreement of All

Appellate Court Presidents on Organization, Place and Time for Holding Joint Meetings of Appellate Courts until 2018 and the meetings of all higher courts in the territorial jurisdiction of the Appellate Court in Kragujevac which were held in accordance with the Plan for Joint Meetings of Higher Courts in the Territorial Jurisdiction of the Appellate Court in Kragujevac, that had been adopted earlier.



The busiest department of the Appellate Court in Kragujevac was the Civil Department.

This department saw an increase in the number of incoming cases by all types of disputes, particularly of cases pertaining to property rights, damages and violations of human rights.



BACKLOG CASES

Given the large backlog of cases in the courts in the territorial jurisdiction of the Appellate Court in Kragujevac and the provision of assistance to lower instance courts for the purpose of reducing the backlog, pursuant to the previously adopted Backlog Reduction Scheme in lower instance courts in the territorial jurisdiction of the Appellate Court in Kragujevac, teams for monitoring backlog reduction progress in courts with the largest backlogs were formed requiring mandatory participation of at least one judge from the Appellate Court in Kragujevac. These activities contributed to a reduction of the number of oldest backlog cases due to an increase in the number of disposed backlog cases in lower instance courts, nonetheless, the overall backlog increased.

STRUCTURE OF PENDING BACKLOG CASES IN 2017 (Basic and higher courts only, first-instance cases)

The number of pending backlog first-instance cases in higher courts increased from 1,373 in 2016 to 3,271 in 2017, or by 138.24%, resulting from the exceptionally large inflow of cases shown above.

In basic courts, the number of pending backlog first-instance cases increased by 973, or 12.3%.






In the first-instance criminal matter in the period from 2014 to 2017, higher courts reduced the number of pending backlog cases by the date of the initial act by 41 (2014 - 183 cases, 2017 - 142 cases), whereas the number of pending backlog cases in civil matter in the same period increased by 58 (2014 - 128 cases, 2017 - 186 cases).



SPECIAL TYPES OF DISPUTES

Territory of the Appellate Court in Kragujevac was particularly burdened with disputes pertaining to violations of personality rights (army reservists), and there was also a significant number of cases where protection from domestic violence was sought.

Given the higher courts' heavy workload induced by special types of disputes such those pertaining to army reservists whose inflow the judges cannot clear within reasonable time, there is an urgent need to systemically resolve this issue, as well as other problems that might serve as grounds for repetitive cases.

Protection of the Right to a Trial within Reasonable Time


The number of cases in which protection of the right to a trial within reasonable time was sought increased significantly in comparison to 2016 when 4,108 cases were received, given that in 2017 there were 7,577 incoming cases.

There were 5,688 disposed cases in 2017, and those pending – 2,619, mostly in basic courts (a total of 2,449).






APPLICATION OF THE NEW LAW ON ENFORCEMENT AND SECURITY

Systemic measures implemented through the Law on Enforcement and Security yielded good results in terms of a significant decrease in the number of pending enforcement cases. Particularly important is that the falling trend of pending enforcement cases also persisted in 2017.

A reduction in the enforcement backlog cases according to the date of the initial act was noticeable as the enforcement backlog dropped from 236,056 at the end of 2014 to 72,437 at the end of 2017. The age structure of these cases points to a decrease of the oldest backlog cases whose number was halved in comparison to 2014, but also to a decrease of the backlog in all age categories, which in turn highlights the continuous efforts of the court which, by disposing the oldest cases, is not allowing other pending cases to fall into the oldest backlog category.

QUALITY

The ratio of the total number of disposed cases, the number of appealed cases in relation to the number of revoked decisions, expressed in total and through the decisions on merits, indicates the number of cases which were, based on the legal remedy, returned to a lower instance court for retrial.

It would be necessary to monitor the trends in the number of revoked decisions, since they impose a burden on the work of courts, which is why professional training and examination of contentious issues should be used to decrease the number of revoked decisions in cases, so that the case would not have to be decided on again, and the decreased number of revoked decisions will allow judges to devote more time to incoming cases. Reduction in the number of revoked decisions helps increase legal certainty and citizens' trust in the judiciary.



Average duration of the proceedings is decreasing in all the courts, and further efforts should be made to ensure that the court proceedings be disposed within reasonable time.

XIII

CONCLUSION

In 2017, a total of 299,945 cases were disposed on the territory under jurisdiction of the Appellate Court in Kragujevac.

Basic courts disposed 116,776 cases in 2017 upon requests of the citizens for verification of signatures, manuscripts and transcripts, issuing certificates, rogatories, etc., while higher courts disposed an additional 1,330 cases of this type.

The number of pending cases in all the courts in the territorial jurisdiction of the Appellate Court in Kragujevac decreased in comparison to 2014 by 181,532 cases.

The results achieved in 2017 are indicative of the great efforts made by judges and all the court employees.

Commitment of courts to achieving better results and their contribution to improvements in efficiency and quality of the judicial system in 2017 were recognized through the presentation of awards and acknowledgements by the Supreme Court of Cassation to the courts in the territorial jurisdiction of the Appellate Court in Kragujevac, specifically:

- Higher Court in Kruševac was presented with the third award in the category "Year-on-Year Increase in the Number of Total Disposed Cases";
- Basic Court in Ivanjica was presented with the third award in the category "Year-on-Year Increase in the Number of Disposed Backlog Cases in the Court":
- Higher Court in Užice, Higher Court in Kraljevo, Higher Court in Kragujevac, Higher Court in Prijepolje and Basic Court in Sjenica were presented with the acknowledgments for their respective contributions to improvements in

efficiency and quality of the judicial system in 2017; and

- Basic Court in Užice and Basic Court in Požega were presented with acknowledgements for innovations contributing to improvements in the work of the court.

Facing the challenge of a large inflow of cases, as is the case in higher courts, drawn-out election of judges and persistent fluctuation of judicial and non-judicial personnel, the courts have obviously made particular efforts, judging by the results shown above, to improve their performance and successfully fulfill their function.

In the forthcoming period, ongoing activities should continue aimed at further implementing the backlog reduction scheme and preventing caseload ageing, as well as streamlining the court practice and improving the quality of court decisions by way of harmonized interpretation of the law, all this in order to ensure equitable treatment of legal parties before the law and respect for human rights and freedoms.
